Good morning my dear brothers and families 5 April, 2008 AD

This week you have been very much on my mind, realizing that it is long since an appropriate time for me to write to you. Perhaps it was the tone in MC's voice when I called him last that reminded me that you know nothing of me and my family unless I take the time to write.

Thanks brother Cecil, you have been the most faithful to write and I love your letters. All news from outside is a great blessing to me here.

Thanks MC and Sue, you have been the most faithful to send me little contributions to my welfare, it has been a great blessing and helping.

Thanks to Troy and Cecil for taking time from your busy lives to visit me at the hearing in November.

It is a little difficult for me to get my communications straight after Donna's death, and those weeks where it was exceedingly difficult for me to maintain communication other than Cecil's wonderful visits, at least in part to my own confession and action in faith.

I never taught my daughters to write letters so the seed I did not sow has bourn no or very little fruit in letters. Conversations usually last about 8 minutes to talk to everyone in the house and get all the updates. All those times I failed to write to mom and dad I now have a much greater understanding about.

As MC always asks. I am ok on the phone and commissary for now and if I stay here on this new job in a couple of months I will be earning enough to keep me afloat without help. Friends and family have blessed me greatly and there was just one month that I had .89 in the commissary account and got down to 4. for phone before anything came in. Very much like a lot of my life; I was blessed in perfect timing.

A great thanks to Jr. for paying my expenses home for the funeral.

My case is sitting in line before teh Supreme Court on a motion for rehearing. It is of no benefit to tell all the quirks of how it came to this point for I am well aware that all that court stuff just as well be arabic or egyptian hyroglyphics as for your understanding.

God has such great timing. My petition for rehearing was mailed one week after the Supreme Court ruled in a case called Boulware. They decided on 3-3 that deficiency or an actual tax owed is a necessary element of the crime called evasion, and reversed Boulware's conviction on that ground. That same issue is at the forefront of my motion for rehearing, and though I had not seen their decision when I mailed my Motion of Rehearing, it arrived here two days after my mailing; it is applicable and gives reason for hope that I will likewise be proven innocent of this crime. I remain dedicated to seeing truth and justice again rule in our America, and do not fool myself to think that there will not soon be other opportunities to stand for truth and do all to stand; my suit of HIS armor fits well, and I am well accustomed to quenching all the firey darts, not of myself but as a gift from God. Without Him I would have long since surrendered to my own desires; but with him all things are possible; even the healing of our land as promised in II Chronicles 7: 14.

The Children and Karyn are now looking forward to the great adventure of making a family in Idaho; so a little like Job; my wife and children are gone; my home and all I had worked for; so as I contemplate leaving here I am available to wherever God may wish me to go; I have had more than 3 days in this whale of a mess. It is my hope, prayer and declaration of faith that God has now prepared me for over

27 years for whatever tasks he has planned for my future.

Yes; Shelli has declared she has a permanent home for me, and hopes I will stay with them forever; and I am certain she is sincere. It would be very difficult for me to go and become a burden to her and Jeff. I have worked really hard at not interfering in their marriage for almost 18 of their soon to be 23 years. I was way too close the first few years to let Jeff really establish his family. NO I do not claim any perfection on the subject. I am sure Karyn and Dallas would also welcome me, though I personally have no desire for Idaho, or cold winters. And no doubt others would make a place for me, and it may wind up in any of a dozen different locations; my expectation is to go back to Arizona, and establish me in a way that I can visit more regualrly to Idaho. I only interfered with Dalla and Karyn's marriage by negligence, and perhaps keeping the children too long.

As I have often stated the children will be the ones mose affected by this time and case. It will be a God sent blessing for my innocence to be verified. In that little thing so much of my ambition will have been accomplished for America and the younger generations. The thought has been on my mind this week that God spent 40 years preparing Moses in the desert or wilderness for His great work in Egypt. I have now been preparing in man's law, my Egypt, for 27 years, and in God's Kingdom law just 22 1/2. From 20 to 40 was the years those men were assigned to the military and warfare; and America's olan for the maiitias was 17-42. I do hope there is not another 13 or 17 years of prepartion before my mission, and believe ther is not for unlike David I am of full maturity to serve, and called to serve, and am quite comfortable in His armor. I am well schooled in the weapons of this spiritual warfare, and on obeying God rather than man. I humble myself in the acceptable sacrifice of my flesh daily seeking HIs face, Order, and command of all that I do, seeking Him as my God and King to reign over my every thought, word and act so that He knows I can be trusted with these little things for our America, the Nation whose God is the LORD. Yes, it is not for me to know the iming of these things, just as Jesus told the disciples, The Father has reserved timing to his own plan and course; and I patiently wait for His perfect timing.

I know that our nation and people have a lot of repenting to do; and hear all the prophecies and declarations of merchants called preachers about how we are living out revelations now; I also know that men thave profited from those prophecies in every generation I have withessed and every generation in the history that I studied. Jesus said that the generation he lived in would not pass away until all those things were accomplished. I celebrate my little part in sharing that great victory in the spiritual warfare that Jesus declared, and passed on to us, his army of spiritual warriors in the earth, guaranteeing our overcoming of all evil by His own Holy Spirit, the Spirit of truth. So please understand that my fight for truth in all our servant government will be never ceaseing, until all these things are accomplished.

Please always remember that you are loved, and if I am, even the youngest called and chosen to be one for this family I am content with my state adn mission.
