My Reply to the Govomit Response was mailed yesterday; so by the time you receive this it should be posted on the Court's website.

What was the real legal argument?

What is the key sentence to this whole document; clue to the case?

Yes; I know you want my answers; and my reply begins those pretty pointedly. Remember as John often said it was best to give a judge an easy way out of a case; but I did not very well adhere to that advice; because there really is none. For the judge to do anything other than send this to appeals and the Supreme Court again will be very hard; and likely very dangerous.

As I recall it was 87 or 88 that the judge in Las Vegas was blocking IRS cases and making their life difficult in every attempted prosecution. He lasted 2 years before being run off the bench and into jail for tax evasion before another judge; so there are exceptions to judicial immunity.

I have not seen any record of what happened to the 9th Circuit judges who ruled against the IRS in Dixon, 2003, but I have also seen no record of any other ruling from those same judges on IRS matters; and do not have the resources here to see if they were a part of Perlaza, 439 F 3d 1149 (2006)...HINT HINT!!

What kind of a response is...the motion should be denied because of the relief sought...? What does the relief have to do with response to the issues?

Did you notice that Us Attorney again cites Collins, 1990, as meaning that quoting the exact language of the Supreme Court in res judicata is a frivolous taxpayer argument. Yes I have to go find and read the two cases they cited from 2007 and see what arguments are involved. I look forward to the opportunity to ask the Supreme Court and Congress if quoting them precisely, as White acknowledged at resentencing is a frivolous taxpayer argument. How could it be? Where could it be? To whom would that apply?

It would apply, just as it did to Greg Dickstein in Collins; a lawyer, sworn officer of the court suffers what is called a conventional disability; one imposed by contract or status in society; and can not raise such challenges as I have. Also a federal employee, or anyone in the territories and possessions that are directly subject can not raise those issues. I have made no waiver; and my captivity is by piracy and kidnapping without law; so I am not making tax protester arguments but rather sui juris arguments in the res judicata of the Supreme Court and the Statutes passed by Congress; both requiring specific on point, plain english regulations in order to impose any duty whatever; Lanier, 1997, Connolly, 1936.

As you read my Reply you will see that I even missed adequate emphasis on that key phrase.

This appears to be a coded phrase to tell the judge that there is no possible answer to the Motion; and that if he does not disallow my motion too much damage will be done and too much of the fraud exposed. Yes of course, the US Atty expects the Court to continue the fraud and deception without law; expecting, I suspect, that the judge will have too much pride to admit error.
