Page 131: "Sixteenth Amendment
(INCOME TAX)

Passed by Congress July 2, 1909. Ratified February 3, 1913.

Congress is permitted to collect taxes on income regardless of the income's source.

This provision gave Congress an additional power even in spite of article I, Sections 2, 8, and 9, which forbid direct taxes that are not assessed in proportion to the census.

Note: The Sixteenth Amendment modified article I, sections 2, 8, and 9."

P. 21 Article I, Section 9. No Capitation, or other direct, Tax shall be laid, [unless in Proportion to the Census or enumeration herein before directed to be taken].⁵ See sixteenth Amendment.

Page 1

Article I

[Representatives and direct Taxes shall be apportioned among the several States which may be included within this Union, according to their respective Numbers, which shall be determined by adding to the whole Number of free Persons, including those bound to Service for a Term of Years, and excluding Indians not taxed, three-fifths of all other Person.]*

* Changed by section 2 of the Fourteenth Amendment.

Page 2

Section 3. The Senate of the United States shall be composed of two Senators from each State, [chosen by the Legislature thereof,]* for six Years; ...

* Changed by the Seventeenth Amendment

... Appointments until the next Meeting of the Legislature, which shall then fill such Vacancies.]*

* Changed by the Seventeenth Amendment

Page 4

The Congress shall assemble at least once in every Year, and such Meeting shall be [on the first Monday in December]* unless they shall by Law appoint a different Day.
